REPORT

As an important aspect of the Practical Training, LL.B-III and BALL.B-V Year students of D G B Dayanand Law College, Solapur visited the Maharashtra Industrial Development Corporation Police Station, Solapur on 8th and 9th February 2024, for an educational and fascinating experience. The purpose of the hands-on training was to provide the enthusiastic group of Law students a better understanding of day-to-day working of Police Station. This visit was organised by subject teacher Asst. Prof. Arvind N Dede, Asst. Prof. M C Hingmire Sir. The visit began with an informative briefing from the station's officers, who welcomed the students and introduced them to the various aspects of their roles and responsibilities. They explained the structure of the police department, the hierarchy, and the critical functions they perform in maintaining law and order. This session allowed the students to gain valuable insights into the complexities and challenges faced by law enforcement.

The students were then taken on a tour of the police station, where they had the opportunity to witness first-hand the various departments, including the reception, woman help cell, the evidence storage area. They also provided valuable insights into the chain of custody, the importance of maintaining evidence integrity, and the procedures followed during arrests and detention. Furthermore, the students engaged in meaningful discussion with the Senior Police Inspector Kukade, asking questions and seeking clarification on legal procedures, human rights, and the various challenges in policing. This interactive session in which the students also engaged in a Q&A with the officer, discussing the challenges they face, the importance of the rule of law, and the delicate balance between maintaining public safety and protecting individual rights.

The LL.B-III and BALL.B-V year students of D G B Dayanand Law College visit to MIDC Police Station proved to be an eye-opening experience, helping them connect their classroom knowledge to real-world legal practice. It fostered a deeper appreciation for the role of law enforcement agencies and the complexities of the justice system. Such practical exposure is invaluable for budding lawyers as they continue their legal education and eventually transition into the professional world of law.

REPORT:

They shared their information to the public. Student got divided into different teams and visited to the people's house who resides in that locality. THE HIGH COURT OF BOMBAY AT GOA





On January 16, 2024, our group of 39 law students from D.G.B. Dayanand Law College visited 'The High Court of Bombay at Goa' in Panaji as part of the educational tour program. The purpose of the visit was to understand the functioning of the high court and witness court proceedings. We reached near the building of high court and everyone was amazed by seeing the structure of the court. It was a huge building built near the Goa sea.

We arrived at the premises at 1:40 pm and were given a brief introduction about the history, jurisdiction, and background of the Goa High Court by the court staff.

Some key facts:

- The Goa High Court was established in 1982 after Goa attained statehood.
- It has jurisdiction over the state of Goa and the Union Territories of Daman and Diu.
- The court currently has 5 permanent judges including the Chief Justice.

After the introduction, we were allowed to witness proceedings in two courtrooms - one handling civil matters and another dealing with criminal cases. In the civil courtroom, arguments were going on in a high-profile property dispute case. We observed how the two opposing counsels presented their arguments citing relevant laws, evidence and previous judgments. The judge heard them patiently, asking clarifying questions at times.

The criminal courtroom had a brief hearing for framing of charges against some accused in a complex financial fraud case. The public prosecutor submitted the charge sheet documents.

After the courtroom visits, we had an interactive session with the judge of District Legal Services Authority of the High Court. Hon'ble Justice patiently explained various aspects of judicial functioning, important acts and laws, courtroom conduct and ethics. Students got their queries about legal career, judgments, and judiciary satisfactorily addressed. It is located opposite of the Goa secretariat, with ample parking space for everyone, with Huge Tri-color flag which is pride of every Indian. It has water amenities and ponds outside it. The building is constructed by keeping in view of future facilities also. Court has all the facilities inside it like Xerox, stationery, etc.

The first floor has a huge waiting area, fully air conditioned having comfortable sofas for people. They have a huge library facing towards the sea. The library has oldest books of 18th century. All the students were amazed by seeing the books collection of the library. Librarian was guiding us and giving information about the library, how many books are there then the Portuguese laws and how they ruled Goa. Some of the territorial law books, weekly & monthly

magazines. All the students did a tour of library. Then students were divided into two groups and taken to the court rooms. The experience of hearing high court cases was the best experience for all the students. Everyone was overwhelmed for such a nice experience. The court rooms were huge having good sitting capacity & 2 bench judges. After hearing the cases we moved towards the ground floor of the building where free legal aid facilities are provided. There we met a handicapped boy who's studying law and in 3rd year of LL.B. He helps in free legal aid department and helps in arranging event in the court. The district judge Ma'am gave us the overall information about the events of the court. We all were inspired & motivated by him. District judge Ma'am told us about her social work.

Overall, it was an insightful and enriching experience that gave us a closer look at the real-world legal system and working of the high court. We are thankful to the Goa High Court for enabling this educational visit.

They shared their information to the public. Student got divided into different teams and visited to the people's house who resides in that locality. They enquired and asked their problems and noted down it to discuss and assured them all kind of legal assistance.

Legal Aid Clinics basically serve the purpose of providing legal advice not with the aim of earning profit but in General Public Interest. In law schools, though knowledge of law is thoroughly imparted. However theoretical knowledge is not sufficient when its applicability is not known. Opportunities for mootings are also limited. Students pursuing law have zeal and enthusiasm to provide legal services. Legal aid clinics thus serve the purpose, the first that they provide free legal services to economically weaker people and second, they direct the energies of the students of law in contributing to the society. These students are headed by their teachers. The members of the Legal Aid clinic are engaged in spreading legal awareness in rural areas through street plays as well as legal aid camps where they make tire target population aware of different legal service programs and guide them to avail these facilities.
