This MoU between Abhinav Skill Development & Education Center, Solapur and Franchise Partner assigns herewith on 15/02/2024. By MANAGING DIRECTOR, on behalf of Abhinav Skill Development & Education Center, Solapur, and, for organizing the Skill Development training programs. D.G.B DAYANAND LAW COLLEGE, SOLAPUR, have submitted proposal for empanelment of firms for implementing the training programs as per proposal on the basis of the terms and conditions mentioned below.

Franchise Partner has agreed to impart skills development training/s to only Unemployed Youth as per details mentioned in the proposal submitted by Franchise Partner. Franchise Partner to ensure that all the trainees selected in the batch are unemployed and domicile of Maharashtra.

Franchise Partner has agreed to impart skills development training/s under EMPLOY / TRAIN & EMPLOY to unemployed youth as per details mentioned in the norms.

TRAIN & EMPLOY

1) Mobilization

- a. Franchise Partner & Abhinav Skill Development & Education Center, Solapur to do mobilization of the candidates and submit the details of the candidates like candidates form, Marklist, aadhar card, 2 Photo etc.
- b. Mobilized and selected candidates should not be less than 18 years of age as on start date of training.
- c. The candidates should be selected only subject to their eligibility regarding Marklist, aadhar card & benefit of state of Maharashtra.
- d. The primary selection of candidates for the skill development training/s will be done by Franchise Partner, however, Abhinav Skill Development & Education Center, Solapur will also supervise the selection process. Franchise Partner, shall submit the details of all the candidates to Abhinav Skill Development & Education Center,

Solapur before 15 days of start of the training.

2) Course Commencement

a. Franchise Partner shall start any course only after written confirmation has been received from Abhinav Skill Development & Education Center, Solapur

b. Infrastructure

1. Franchise Partner shall conduct the course at its authorized training centers only, approved by Abhinav Skill Development & Education Center, Solapur.
2. Franchise Partner shall ensure that the training centers should have the minimum facilities like good classrooms (ventilated & sufficient light) equipment's, Lab, computers etc. for conducting training
3. Franchise Partner has to inform Abhinav Skill Development & Education Center, Solapur in case of any change in higher authority of Firm, SPOC person, Name, Signature etc. immediately.

c. Course Content

1. Abhinav Skill Development & Education Center, Solapur shall ensure that the course material, syllabus, training schedule etc. are given to all the candidates immediately after the commencement of the course and should be as per latest industry standards
2. Abhinav Skill Development & Education Center, Solapur shall ensure that all trainers deputed by them have the relevant education, experience and skill set for conducting the proposed

Monitoring during Training

a. Abhinav Skill Development & Education Center, Solapur shall audit the training programs randomly by authorized persons and it's binding on Franchise Partner to extend all support to Abhinav Skill Development & Education Center, Solapur, The Franchise Partner will rectify any short comings observed during the visits on an immediate basis and inform Abhinav Skill Development & Education Center, Solapur accordingly.

4) Assessment & Certification

- a. Abhinav Skill Development & Education Center, Solapur shall provide certificates to the trained candidates on last day or any convenient day of closing as agreed. The certificate should be Abhinav Skill Development & Education Center, Solapur For MSSDS project, assessment will be conducted by Assessing body authorized by MSSDS.

5) Attendance

- a. Franchise Partner & Abhinav Skill Development & Education Center, Solapur shall take special efforts to ensure that each candidate is attending the training minimum 95% of working days in a month. Attendance records will be maintained in physical and biometric attendance registers submitted to Abhinav Skill Development & Education Center, Solapur not later than 4th day of the subsequent month in the prescribed format given by Abhinav Skill Development & Education Center, Solapur

6) Financial Terms and Conditions

1. Franchise Partner will be incentivized for placing the candidates on the following terms and conditions.

Payment – Per Student 500 Rs & 2 Projectors for 2 Class rooms

Amount to be released Criteria –

1. 50 % Payment batches start after 4 th month





This Memorandum of Understanding (MoU) is effective as of - day of --- 202 to establish an affiliation by and between Bhai Chhannusingh Chandele College of Social Work, Solapur, established as College of Social Work which is approved and aided by Government of Maharashtra and Affiliated with Punyashlok Ahilyadevi Holkar Solapur University, Solapur Since 1994, hereinafter referred to as BCCMSW, Solapur, of the FIRST PART, And

(Name of the concerned College) and brief introduction, hereinafter referred to as ---, of the SECOND PART, for the Academic Tie Up. The aforesaid institutions are hereinafter referred to individually as institute and collectively as institutes.

Introduction:

BCCMSW, Solapur and ----- have many areas of common interest in education. In some of these areas, the degree of mutual interest is so great that considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academics, education and research, library. Collaboration will be established within the principles set out in the following sections.

1. Object: Both Institutes agree to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity. The two institutions shall seek to promote: a. Academic & Administrative Tie Up (Faculty/Staff/Book Exchanges) (i) The exchange of faculty to the mutual benefit of both institutions, (ii) Collaboration in teaching, research and development, and

consultancy studies in the field of mutual interest, (iii) The exchange of academic materials and publications, (iv) Conducting lectures, (v) Undertaking joint research, (vi) Attachment of staff for purposes of curriculum development and review, attendance of courses, upgrading of teaching and research skills, (vii) Participating in seminars, symposiums, and other types of academic discussions, (viii) Co-supervising students, (ix) Conducting joint consultancy work. (x) Exchange of Library Resources. (xi) Student Exchanges: Student exchange activities cover visits to either institution for any of the following purposes: (i) participating in research; (ii) participating in taught courses; (iii) involvement in activities.

b. Other Areas: (i) to exchange information on research and educational programs (ii) to exchange information on teaching, learning material and other literature relevant to their educational and research programs, (iii) to organize education programs/lectures on topics of mutual interest and to invite each other's faculty to participate therein, (iv) to organize jointly seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein, (v) to propose and engage in research or training programs, and to invite each other's faculty to participate therein, (vi) to exchange, on a reciprocal basis, students for purpose of education and research, (vii) the provision of cultural and intellectual enrichment opportunities for staff and students of both institutes, (viii) to permit students, staff and faculty members to use library facility.

Coordination: Each institution shall appoint one member of teaching/administrative to coordinate the programme on its behalf.

Confidential Information: BCCMSW and ---- does not absolve any confidential information during any activity.

Validity The Memorandum shall remain in force for a period of **three (03)** years commencing from effective date. Institutions may extend the term by written agreement Signed by both after review.


